

# Crank Cycle Coaching Prize Draw Promotion Terms and Conditions

## Promoter

1. The promoter for this prize draw is Crank Cycle Coaching LTD
2. By entering this prize draw each entrant accepts these terms and conditions.

## Who can enter

1. Employees of the promoter, its associated companies, agents, third parties and anyone else professionally connected with this prize draw, and their close family members, aren't eligible to enter this promotion.
2. Only one entry per person.
3. No automated, bulk or third party entries are permitted.

## The prize

1. The prize consists of 3 months Event 1:1 Cycle Coaching with Simon which can be redeemed within 6 months of the competition closure.
2. No cash alternative to the prize will be provided. The promoter reserves the right to substitute the prize or any part of the prize with one of equivalent or greater value.

## How to enter

All reasonable efforts will be made to contact the winners, but if the promoter is unable to contact any winner by Friday 17th May, the promoter may at its discretion disqualify that winner and choose an alternative winner at random from the remaining valid entries subject to the same terms and conditions.

## Prize redemption and restrictions
